

VALET NETWORK — CHAUFFEUR CONFIDENTIALITY & NON-DISCLOSURE AGREEMENT

Mutual NDA for personnel engaged through the VALET Network

This Confidentiality and Non-Disclosure Agreement (the "Agreement") is entered into between VALET Network ("VALET") and the undersigned chauffeur, driver, or applicant ("Driver"), effective on the date of signature below.

1. Confidential Information

"Confidential Information" means any non-public information Driver learns in the course of, or in connection with, providing chauffeur services through VALET, including: the identity, residence, family, staff, movement patterns, itineraries, vehicles, security arrangements, health, and personal or business affairs of any client, principal, guest, or their household; the contents of conversations overheard in the vehicle; and any commercial information belonging to VALET (rates, dispatch procedures, roster, technology).

2. Non-Disclosure

Driver shall not disclose Confidential Information to any third party, and shall not publish, post, photograph, film, record, tag, geolocate, or reference any client, principal, itinerary, or vehicle on any social media, messaging platform, press outlet, blog, or public forum, at any time, during or after Driver's engagement with VALET. Driver shall not confirm or deny any client relationship, including to friends, family, or the press.

3. No Photographs or Recordings

Driver shall not take photographs, screenshots, audio recordings, or video recordings inside a client vehicle, at a pickup or drop-off address, at a residence, hotel, venue, or airport FBO, or of any client, guest, staff member, or license plate — except as strictly necessary to document a safety incident and immediately reported to VALET.

4. Return and Destruction

Upon request or upon termination of engagement, Driver shall promptly return or permanently delete all Confidential Information in Driver's possession, including notes, contacts, addresses, and any images or recordings, and shall certify such destruction in writing on request.

5. Term and Survival

The obligations in this Agreement begin upon signature and continue indefinitely, surviving termination of Driver's engagement with VALET.

6. Remedies

Driver acknowledges that a breach of this Agreement would cause irreparable harm for which monetary damages would be inadequate, and that VALET shall be entitled to seek injunctive relief in

addition to any other remedies available at law, including recovery of legal fees.

7. Governing Law

This Agreement is governed by the laws of the State of New York, without regard to conflict-of-law principles. The parties consent to exclusive jurisdiction of the state and federal courts located in New York County, New York.

8. Entire Agreement

This Agreement, together with any driver services agreement and the VALET Master Service Agreement, constitutes the entire agreement between the parties regarding confidentiality and supersedes any prior understanding on that subject.
